ORDER U/S 12AA(b) OF THE INCOME-TAX ACT, 1961:

The above Trust is constituted by an original trust deed dated 26.08.1985 and a supplementary trust deed dated 08.01.2010 duly registered with the Sub Registrar, Tirukoilur.

2. The above trust has filed an application in Form No.10A for Registration u/s.12A(a) of the Income tax Act, 1961 on 25.06.2014.

3. The application has been entered in the register meant for applications in C.No.9165E(1696)/CIT/PDY/2014-15. The Trust is, accordingly, registered u/s 12AA(b) of the Income tax Act, 1961 as a Public Charitable Trust. This registration is granted from the assessment year 2015-2016 i.e., from the assessment year immediately following the financial year in which the application is made.

4. The registration does not ipso facto exempt the income unless the provisions of Section 11, 12, and 13 of the I T Act, 1961 are adhered to.

5. The registration may be cancelled in terms of the provisions of section 12AA(3) if at any stage it is found that the activities of the applicant trust/institution are not genuine or are not being carried out in accordance with the objects of the trust/institution.

6. The applicant shall comply with the provisions of Section 139(4A) of the Income tax Act, 1961.

7. Any amendment to the clauses would be effected with the prior approval of the undersigned, failing which the registration granted as above will be liable to be withdrawn.
